Background:

SoftChalk Cloud is a digital curriculum authoring platform that educators use to create web-based learning content. This learning content (html page content) is delivered to students who use a web browser to view the learning content. SoftChalk LLC is committed to ensuring that the web-based lessons that SoftChalk Create produces are usable and accessible by all students.

As part of this commitment, SoftChalk has designed and developed SoftChalk Create, the authoring tool used by educators to produce content in accordance with the internationally recognized Web Content Accessibility (WCAG) Guidelines 2.1 and VPAT version 2.4. We provide an accessibility conformance report to assist our customers in making an assessment of the accessibility of our products.

•All aspects of the web content pages are accessible via the keyboard tab and arrow keys. •When creating a lesson, the content author may optionally include an interactive activity. Of the 20 interactive activities that can be used in SoftChalk content, 17 of them are keyboard accessible and 3 are not. By keyboard accessible we mean that the student can complete the activity using only the keyboard to access the activity. The 3 exceptions include: Pairs, Align, and Selection activities.	Open	Planned	This work is currently underway. SoftChalk anticipates release of updated interactive activities for the 3 referenced activities by September 2020.	As an alternative to using the activities types that are not keyboard accessible, the content author may choose to use any of the 17 activity types that are accessible via the keyboard, or they can use the interactive quiz questions that are accessible via the keyboard.	SoftChalk has been in the process of redesigning all of the activities to ensure they are accessible via keyboard and screenreader (JAWS). Of the 20 activities, all but 3 are currently accessible via the keyboard. Eleven of the 20 are also screen reader accessible. We anticipate that all activities will be key board accessible by Sept 2020, and all activities will be screen reader accessible by the end of the year 2020.

SoftChalk has focused its energies on ensuring that the learning content generated by the SoftChalk Cloud platform is as fully accessible as possible. The accessibility of the authoring platform itself, for impaired content authors, has not been evaluated. We believe the platform does not currently meet accessibility requirements for authors with disabilities. We do not currently have a timeline for this development work — it is our understanding that it will be a significant undertaking, and most likely a multi-year effort.
